

Young Entrepreneur of the Year Competition Application Form

Program Overview

Junior Achievement of Wisconsin is proud to present the Young Entrepreneur of the Year Competition (YE) — a statewide opportunity celebrating high school students in grades 9–12 who have successfully launched and operated their own business ventures.

This is a competitive program where four finalists will be selected to present their businesses in a taped television event in Milwaukee, WI, competing for scholarships and additional recognition.

The application is now open year-round, with finalist decisions will be made the first week of January.

Once event dates are confirmed, applicants will be notified and given the option to either continue with consideration for the current year or defer their application to the following cycle.

Eligibility

Applicants must meet the following criteria:

- Be a student in grades 9–12, a legal U.S. and Wisconsin resident, and currently enrolled in a high school (public, parochial, private, virtual, or homeschool).
- Be the owner(s) or manager(s) of an active for-profit business started and operated by the applicant. Businesses may be seasonal but must have been in operation since at least January 2025.
- Maintain continuous ownership/management of the business throughout its existence.
- Previous YE winners are not eligible.

Finalists must be available to travel to Milwaukee, WI for the live, in-person competition. JA will provide one night of lodging. *Note: If you live in Northern Wisconsin see Northern Wisconsin Applicant section below.*

Award and Recognition

Four finalists will present their business to a panel of celebrity judges during a televised statewide competition, typically held in February or March in Milwaukee. The event will be live streamed and later broadcast on the local FOX affiliate.

- Grand Prize Winner: \$5,000 scholarship + recognition on the WI Department of Public Instruction's Young Entrepreneur webpage.
- Runners-Up (3): \$1,500 scholarship each.
- Viewer's Choice Award: \$500 cash prize.

Selection Criteria

Finalists are selected based on:

- Business success (financial performance, marketing, innovation, and more)
- Strategic thinking and long-term vision
- Entrepreneurial leadership and professionalism

Application Process

Applications are accepted year-round, with final decisions made the first week of January each year. A completed application includes:

- Application form
- Signed media release and permission slip
- Headshot
- Business video

Once your online application form is submitted via email, you will receive a confirmation email and a personal link to upload your video and headshot.

When event dates are finalized, you will be notified and asked to confirm your availability or opt to defer your application to the following year.

Northern Wisconsin Applicants

Students who live in Northern Wisconsin will use this same form to apply for the **Northern Wisconsin Live Competition**, held on **January 26th**. One winner from that competition will advance to the statewide event and receive preferential consideration. Prizes include a \$2,000 award for the first-place winner, as well as an additional prize awarded based on public voting through social media.

If Northern Wisconsin applicants are not selected for the regional event, their applications will automatically be considered for the statewide competition — giving them two chances to be selected.

Video Components: The following statements or questions must be addressed in the video clip; please script your video to include these questions/statements, **in the order listed below**:

- Please introduce yourself and your business:
- What is your name?
- What is the name of your business?
- Please tell us about your business. For example, what is the purpose or goal of your business? What products and/or services do you offer? What customers are you targeting? What unique benefits does your business offer your customers?
- Why did you start your business? What inspires you and how did you turn your vision into a reality?
- Please tell us more about yourself and how you make your business succeed. How have you demonstrated commitment, vision, and leadership through your business?
- What is your strategic vision for the business? What long term goals have you set (for example, future products/services, future markets/customer segments, employees, equipment, etc) and how are you going to achieve those goals?
- Please provide us with a financial picture of your company, including
 - How your business makes money
 - Major sources of revenue and expenses
 - Assess your current level of profitability: Are you currently profitable? If not, how far off are you and what will it take for you to become profitable?
- Please tell us anything else you think would be interesting that defines and differentiates your business. For example, are there any causes your business supports?
- Why do you think your business should be selected as a finalist and considered for the grand prize?

Video Format: Use the highest video quality setting there is on the camera in landscape mode. Preferred file format is: Mp4.

Sound Quality: Use a microphone, if available, to improve sound quality.

Length of Video: No more than 7 minutes for a creative video.

Appropriateness: All videos must be clean, professional and appropriate. No obscene or vulgar language and no sexual overtones will be accepted. Content must be reviewed by an adult prior to submission.

Media Permission Slip and Media Release: Completed and signed parental permission forms and media release must be submitted at the same time as the video clips for any minor who appears in any way in a video clip.

Deadline: All submissions (including video) must be received no later than **midnight on Monday, January 6th, 2026**.

Video Submission: You'll receive an email confirmation we received your email and an invitation to upload your video file and headshot using a customized Google Folder link.
